College Grievance Redressal Cell

- 1) All grievances in the college shall be addressed to the college grievance redressal cell.
- 2) The college will follow the principles of natural justice while redressal of grievances.
- 3) The college will redress the complaint within fifteen days from the receipt of the complaint.
- 4) The College Grievance Redressal Cell will suggest a remedial plan with a view to reducing and curbing the number of complaints.
- 5) The College Grievance Redressal Cell will provide a copy of the order to the aggrieved person or persons.
- 6) The University shall appoint an Ombudsman to hear and decide appeals against the decision of the Constituent Grievance Redressal Cell or the University Grievance Redressal Cell.

Grievance and Redressal Cell

The Grievance and Redressal Cell desires to promote and maintain a conducive and unprejudiced environment for student teachers. It attends to the grievances and complaints registered by anyone with regard to the activities of the Institution, and in particular, those made by students. The Cell ensures effective solution to the grievances, using a fair approach. The Grievance and Redressal Cell enables the students to express their grievances by initiating and following the grievance procedure in accordance with the rules and regulations of the College. The cell meets periodically, examines the nature and pattern of the grievances.

Objectives

- 1. To develop an organizational framework to resolve grievances of the students and other stakeholders.
- 2. To ensure effective solution to the stakeholders' grievances with an impartial and fair approach
- 3. To investigate the reason of dissatisfaction.
- 4. To enlighten the students on their duties and responsibilities.

Functions of the Grievance and Redressal Cell

- 1. Provides information about the Cell's objectives and mode of operation through the website and handbook.
- 2. Informs students of the process for registering of grievances in the Induction Programs.
- 3. Acknowledges and Analyzes the grievances.
- 4. Seeks a solution through decision-making process
- 5. Reports the grievances and records how they were redressed.
- 6. The procedures made known through the Hand-book, given to each student at the beginning of every academic year, and also in the Value Education classes taken by the Class-in Charge teachers.

Procedures:

The Grievance and Redressal Cell shall receive and redress the grievances of the following issues:

- Academic issues pertaining to teaching, learning and evaluation activities.
- Student-teacher, student-student grievances



- * Grievances related to library and IT services.
- * Grievances related to sports, cultural
 - The grievances shall be redressed depending on the nature of the grievance.
 The Grievances are invited through suggestion boxes provided in each floor of the building.
 - 2. Department level counseling is offered where the matter can be resolved
 - Grievances pertaining to academic and internal evaluation shall be redressed at individual/faculty / principal level.
 - 4. For other grievances that require review shall be redressed by receiving written and signed application.
 - As soon as the application is received the Redressal Committee shall review
 the complaint and invites both the parties for discussion. The outcome of
 the discussion is reported to the Principal for further action to be taken.

Redressal of Grievances

The grievances are redressed at the earliest by issuing warning letter, memo and reformation remedies. Priority is given according to the urgency of the complaint. In all cases the aggrieved is informed of the measures taken. Checks in the system are introduced to ensure there is no repetition of the same complaint. All the grievances concerning to women harassment and ragging shall be dealt by the respective committees as per the prescribed procedures.






Anti-Ragging & Anti-Sexual Harassment Cell

As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:

- 1. Any act of Indiscipline, Teasing or Handling with Rudeness.
- 2. Any act that Prevents, Disrupts the Regular Academic Activity.
- 3. Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
- 4. Any Act of Financial Extortion or Forceful Expenditure.
- 5. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
- 6. Any Act of abuse by spoken words, emails, SMS or public insult etc.
- 7. Any Act of injury or infringement of the fundamental right to the human dignity.
- 8. Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
- 9. Any unlawful assembly or conspiracy to ragging.



Punishment to those found guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments.

- 1. Debarring from appearing in any sessional test / University Examination.
- 2. Suspension from attending classes and academic privileges.
- 3. Withdrawing all College benefits.
- 4. Suspension from the college for a period of one month.






