



### Sir/Madam,

I am happy to inform you that you have been selected (\*\*Please see overleaf) for the above mentioned programme to be held from 10.07.2018 to 30.07.2018. This selection is subject to following conditions:

- 1. that your College is recognised by UGC u/s 2 F or is affiliated to the University.
- 2. your college/institute/university will relieve you for attending the programme and will treat you 'on duty' during the programme period.
- 3. that you will attend the programme for full duration (3 weeks).
- 4. that you will appear/participate for all the academic evaluations conducted during the programme. You will participate actively in various activities of the programme viz. seminars, discussions, short projects, lectures, examinations, etc.
- 5. As per the UGC directives, the programme involves minimum 108 contact hours. You will attend all the lectures regularly and punctually.
- 6. that you agree to abide by all the instructions given by the Director, UGC-HRDC/ coordinator of the Refresher Course from time to time, during the programme.

You are advised to **communicate your acceptance** by e-mail immediately as per new guidelines of the UGC Dt. 01.02.2015 the participants of the Refresher /Orientation Programmes have to pay Rs. 1000/- (Rupees One Thousand Only) (**Non-Refundable**) as Registration Fee and **Your admission to the course will be confirmed only after receipt of Registration Fees. (Please see enclosed proforma)** 

The participants are entitled to draw T.A. as per U.G.C. norms for attending the course. The teacher participants are eligible to travel by private/Government luxury, semi-luxury bus/III AC rail from their college town to Pune by shortest possible route. Railway/actual bus fare will be paid to the participants only on the production of confirmed rail/bus tickets; failing which they will be paid second-class rail/ordinary state transport bus fare. (Please note that participants from college, institute, which are not covered under purview of section 12(b) will not be paid TA as per UGC guidelines). You are required to submit the certificate of recognition under section 12(b) at the time of registration.

Participating teachers are requested to note that as per UGC notification no F.No.1-13/2017 (HRDC) dated 4 June, 2018, HRDC will not pay DA to participating teachers. Hence, charges toward lodging and boarding will be borned by the participating teachers.

Please note that it is obligatory on part of the teacher to undergo the Orientation/Refresher Programme as per the University of Pune statutes/UGC directive/Government resolution No. NGC. 1286/(1224)/UNI-4 in this behalf. The details regarding course content, etc. will be given to you at the time of joining the course. If you need

accommodation during the course period, you will be provided with accommodation on First-come-First-serve-basis (based on availability on the campus / venue). The details of hostel accommodation/facilities are given below.

Working of the Refresher Programme will start at 10.00 a.m. on 10.07.2018 in the Department of Education & Extension, Savitribai Phule Pune University, Pune. You are advised to be present on time. Please note that you have to submit signed & stamped relieving order on college letter head at the time of registration (format for the same is enclosed for your reference).

For Teachers of Maharashtra only

\*\* Your attention is drawn to the Maharashtra State Government Resolution No. NGC/1289/(1605)/UNI-4, dt. 20th July, 1993, stating that "If the candidate willfully fails to participate in the two refresher courses in the event of opportunity having been offered to him, this shall affect on stoppage of increment accruing after the said period and also other benefits. Increment and further benefits of promotion etc. shall be considered on fulfilling the aforesaid condition".

The UGC-HRDC will communicate names of the teachers who willfully fail to participate in the Orientation/Refresher Course, to the Directorate of Higher Education, Pune.





Formal Inaugural Session had conducted where Dr.Sanjeev Kumar Pandey sir summarized rules and regulations of this STC. importance of Short term course and Need of the above theme(Gender Sensitization) of STC was elaborated.

Day 1-2 session 20th Dec 2021

Introduction to Gender Sensitization by Dr.Yogita Mandole Sr. assistant Professor of Smt. Surajba College of Education, Mumbai. She has elaborated the difference between the terms SEX and GENDER. Sex refers to the biological differences between males and females physiology. And Gender refers to the economic, social, and cultural attributes and opportunities associated with being male or female. Question was raised why gender considers as Women's Empowerment? Gender includes both women and men, however, in most cases focus is given to only women. It is because of imbalance and unequal status of women in most of the societies where women do not have the same opportunities and personal freedom as men do. Therefore there is a need to focus women compared to men.

Gender roles are learned behavior in a given society/community or other special group that condition us to perceive certain activities ,tasks and responsibilities as male or female. In most present day societies, this sexual division of labour is rooted in what is technically known as a production-reproduction distinction.

Gender stereotypes, Gender ideology, gender analysis, meso level, macro level were discussed. Gender sensitive indicator concept made clear. Session was followed by discussion and question answer.

Gender Sensitization: Awareness of Men Rights By Dr.Hema Mehta Asso.Professor ,Tolani College of Commerce,Mumbai.Madam gave general observation Men tolerate and stay in abusive and violent relationship for many of reasons. Some of the reasons "why men tolerate domestic violenceand abuse" are the belief and hope that things would get better, fear of losing social respect and position, protection and love towards their children and family. 
